The European Regional Development Fund (ERDF) provides funding to public and private bodies in all EU regions to reduce economic, social and territorial disparities.

The **European Regional Development Fund (ERDF)** supports investments through dedicated national or regional programmes to make Europe and its regions more competitive and smarter, greener, more connected, more social, and closer to citizens.

It follows the top two priorities of the new cohesion policy:

1. support for innovation, the digital economy and SMEs delivered through a smart specialisation strategy (PO1);
2. and a greener, low-carbon and circular economy (PO2).

It also introduces a list of activities that are not to be supported by the ERDF: the decommissioning or construction of nuclear power stations, airport infrastructure (except in the outermost regions) and some waste management operations (e.g. landfill).

ERDF has two main goals, namely:

- **Investment for growth and jobs (Operational Programmes)**
–to strengthen the labour market and regional economies.
- **European Territorial Cooperation (Interreg programmes)**
–to strengthen cross-border, transnational and interregional cooperation within the EU. To know more about Interreg please consult the dedicated leaflet below.

The ERDF finances programmes in **shared responsibility** between the European Commission and national and regional authorities in Member States. The Member States' administrations choose which projects to finance and take responsibility for day-to-day management.

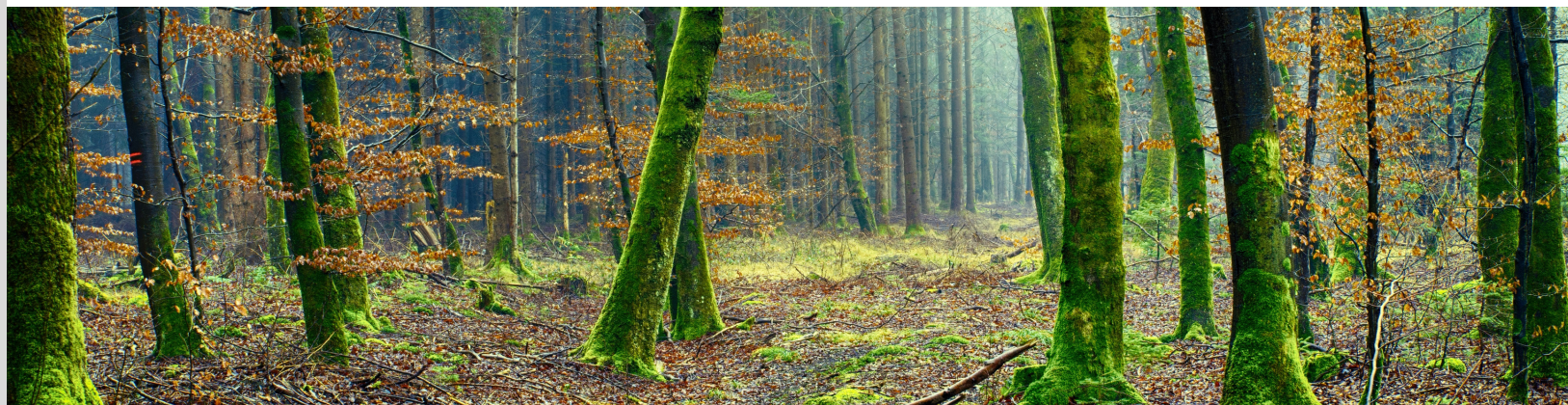

INTERREG A CROSS-BORDER

It aims to enhance cross-border cooperation between NUTS III regions from at least two different Member States lying directly on the borders or adjacent to them.

As such, Interreg A can be used to invest in:

- *Innovation*
- *Health care*
- *Education*
- *Employment*
- *Labour mobility*

In addition, *Risk prevention and emergency response*, as part of climate adaptation, can be financed by this programme.

The projects can benefit from additional funding from ERDF, IPA or NDICI.

This programme can finance climate change adaptation strategies such as flood management or nature based solutions.
